Previously Opening Permission has been accorded to the classes **I to VII** from the year **2017-18** in respect of **Srishti World School, Sector - XI, Ukkunagaram, Visakhapatnam** vide reference 1st cited.

The Correspondent, **Srishti World School, Sector - XI, Ukkunagaram, Visakhapatnam** has submitted the application for Provisional Temporary Recognition for classes **I to VII** class English Medium for the years in the school from **2017-18 to 2021-22** in the reference 2nd cited.

The Mandal Educational Officer, Parawada has verified the application for Provisional Temporary Recognition with reference to the conditions laid down in the previous orders and G O Ms.No.1 Edn., dated 01.01.1994 and submitted a report in his letter 4th cited.


The District Educational Officer, Visakhapatnam hereby granted Provisional Temporary Recognition for a period of **'5' years** i.e., the academic year from **2017-18 to 2021-22** for the classes **I to VII (English Medium)** in respect of **Srishti World School, Sector - XI, Ukkunagaram, Visakhapatnam** subject to fulfilment of the following conditions.

1. That the Educational Institution shall serve the needs of the locality more particularly
2. That the institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
3. That the school timings vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
4. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
5. That the results of institution shall be satisfactory every year.
6. That the records/ accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
7. That the list of Governing Body shall be furnished to the District Educational Officer, every year.
8. That the pay structure/fee structure fixed by the Governing Body shall be got approved by the District Educational Officer, every year.
9. That all the conditions prescribed in the G.O.s and other orders which are not specified in this order shall be complied with
10. That the school shall not be closed without giving notice both to the parents/ District Educational Officer, and competent authority at least six months before.
11. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
12. That the society shall submit proposal for Renewal of Provisional Temporary Recognition sufficiently in advance i.e., at least six months prior to the date of expiry of the present recognition.
13. That the society shall provide fire safety measures in the school as per the No objection certificate.
14. The management informed that no thatched roof accommodation is allowed to run the school.
15. Proper and adequate sanitation facility shall be provided for students especially for girl students.
16. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
17. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments.
18. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
19. The school shall have first aid kit and the teachers shall be trained in first aid.
20. The Correspondent of the concerned school is hereby informed to file an affidavit every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
21. That the management shall obtain and submit the structural soundness certificate every year before reopening of the School for the academic year.
22. That the management shall take every responsibility for the timely safely and comfortable mobility of the School Children from the residences to School and vice versa.
23. That the School Van should be ensured road worthy for the transportation/ mobility of School Children.
24. That the School Bus should be free from all taxes due and should be maintained with regular checks by authorized mechanism of Periodically/ as and when required without causing any sort of dislocation for the School Children opting the bus facility.
25. That the management shall engage skilled experienced and authorized drivers having good health and good vision for the School Van.
26. That the management shall ensure the vehicle and safety girls be provided to the windows of the Vehicle.
27. That the management shall ensure the Accounts of the School audited by an authorized Chartered Accountant every year and submit
28. The management is hereby informed that the recognition is being given purely on temporary basis and is subject to the report of state level inspection and vigilance committee regarding fulfillment of all the pre-requisite conditions under A.P. Education Act 1982 and if later found that the school has not fulfilled any pre-requisites as stipulated, the recognition now being given is liable to be withdrawn at once.
29. The management should display fee structure and pay structure and qualified teachers list on the notice board
30. The management shall follow the rules and regulations issued by Traffic Department from time to time. If any compliant received from the Traffic Department, the Temporary Recognition now issued shall be cancelled at any time without giving notice.

If the management fails to comply with the above conditions promptly the Recognition now granted will be reviewed.

Previously opening permission has been accorded to the classes VIII to X under E.M. to Srishti World School, Sector-XI, Ukkunagaram, Visakhapatnam from the year 2019-20 vide reference 4th cited. Now the Secretary & Correspondent, Srishti World School, Sector-XI, Ukkunagaram, Visakhapatnam has submitted the application for granting of provisional recognition for class VIII to X under E.M. for the years from 2019-20 to 2028-29 vide reference 5th cited. In the reference 7th cited, the District Educational Officer, Visakhapatnam has verified the application and submitted for granting of Provisional Recognition with reference to the Inspection Report of the Inspecting Officer (vide reference 6th cited) and as per the G.O.Ms.No.1 Education, Dated.01.01.1994 and its amendments.

Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Visakhapatnam who is the competent authority is hereby granted provisional recognition to Srishti World School, Sector-XI, Ukkunagaram, Visakhapatnam for a period of 9 (Nine Years) i.e., for the academic years from 2019-20 to 2027-28 for the class VIII to X under E.M. based on the report of the District Educational Officer, Visakhapatnam subject to fulfillment of the following conditions.

- 01 That the society shall abide by the rules and regulations made by the Government or authorized officer from time to time.
- 02 That the Educational Institutions shall serve the needs of the locality more particularly.
- 03 The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
- 04 That the school timings, vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
- 05 That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed by the management with own funds as per the staff pattern.
- 06 That the results of institution shall be satisfactory every year.
- 07 That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
- 08 That the list of Governing Body shall be furnished to the District Educational Officer every year.
- 09 That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
- 10 That all the conditions prescribed in the said G.O.'s and other orders which are not specified in this order shall be complied with.
- 11 That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
- 12 That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13 That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
- 14 That the society shall provide fire safety measures in the school as per the No Objection Certificate.
- 15 The management is informed that no thatched roof accommodation is allowed to run the School.
- 16 The management shall provide proper adequate Toilets / sanitation facility to the students & Staff.
- 17 Proper and adequate safety measures shall be taken for the students within the school campus and also near the school premises.
- 18 The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
- 19 The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the students.
- 20 The school shall have first aid kit and the teachers shall be trained in first aid.
- 21 That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail.
- 22 The management of the school is hereby informed to renew sanitary certificate from the competent authority ever year and same should be submitted to the District Educational Officer, Visakhapatnam through the inspecting officer.
- 23 That the management of the school is hereby instructed to renew the Fire NOC every year without fail and the management shall provide Fire extinguishers in the premises of school without fail.
- 24 That the management shall ensure the Accounts of this school are audited by an authorized Chartered Accountant every year.
- 25 That the management has to maintain trained and qualified of APTET Teachers at all time.
- 26 The Management is hereby informed to file an affidavit before April 30th of every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.

If the management fails to comply with the above conditions promptly the Recognition now granted will be reviewed.
